## I. Background of the Project

Food and Nutrition Security in Rakhine State (FNS Rakhine) project, funded by EU implemented by GIZ, is dedicated to “Improving the production, nutrition and market values of small-scale aquaculture in Myanmar’s Rakhine State”. ## II. Objectives

The purpose of the consultancy is to provide the Small-scale Aquaculture Training to ADePT project's targeted aqua-farmers with a comprehensive and practical approach to small-scale aquaculture.

The specific objectives of the SSA training are as follows:

- To improve communities' understanding of aquaculture techniques and improved practices
- To access alternative livelihood opportunities and income for the small-scale fishers
- To reduce the overexploitation of fishery resources

## III. Scope of Work

The details scope of work are as follows:

### 1) Design and development of Training Materials

- Assess the existing materials and documents related with Small-scale Aquaculture
- Develop the training materials including manuals, PowerPoints and supporting documents in close collaboration with NAG program and project team (NAG will provide the reference materials)
- Training Design should be covered the following Four Modules:
  - Pond Preparation and Fish Stocking
  - Aquaculture Management after Stocking and Fish Nutrition
  - Harvesting, Preservation, Marketing and Demo-cooking
  - Disaster Risk Management in Aquaculture

### 2) Delivery of Training

- Conduct two days cluster level training covering Four Modules for five clusters (25 participants per cluster for five clusters- total of 125 participants)

### 3) Training Evaluation

- Pre-test and Post-test (Performance Evaluation) need to be carried out and the results should be compiled at training report

### 4) Reporting

- Submit the training report covering five cluster trainings
