1. Project Background

Smart Power Myanmar has conducted electrification research at your village in November 2021 and interviewed VEC members and some households. During that time, we were at the research stage but now we are in the project implementation stage where we identify villages that want to be connected as part of the program.

The objective of the Shining Bright Project is to increase access to electricity in rural villages where both 11KV lines and transformers have arrived, but many households are not yet connected because of the lack of financing. The main project partners involved are Hana Microfinance which provides loans for households wanting to be connected, Danyarzar EPC Contractor which constructs the distribution network and household connections, and Smart Power Myanmar which organizes and provides support to the village during the implementation.

"Shining Bright Package" includes the *electrification loan* for households to finance the village connection, and *construction* to build the village network and household connections. The loans will pay the EPC for the construction.

2. The Role

Technical Facilitator post is full-time on-the-ground player for the project implementation. Supervised by the Team Leader, he/she has to be responsible for facilitate and technical support to project implementation. It is also responsible for field work-plan and report and modify the electrification guidebook which conduct to implement.

3. Responsibilities

- Organize the Village Electricity Committee (VEC) at the meeting and group discussion.
- Conducting the preparatory and introduction meeting with VEC and villagers at the targeted villages
- Facilitate and coach to VEC to conduct the multi-meeting and group discussion.
- Facilitate and linkage among the partners to achieve objective of the project.
- Develop online communication channel for VEC member to identify overall progress, issue and challenges.
- Conducting the question and answer session with Village Electrification Committee (VEC) and villagers.
- Support and participate to modify the electrification guidebook, electrification material and tools.
- Support and facilitate in the process of village site survey with EPC contractor and VEC.
- Support and facilitate to VEC and villagers when the conducting of training.
- Facilitate VEC and villagers for the loan application process if needed.
- Prepare and submit individual work plan and support to prepare project work plan.
- Prepare and submit monthly report and support project quarterly report and completion report.
- Support team leader to implement the project.
- Monitoring and evaluation the project

- Minimum of 4 years of relevant professional experience in engineering and facilitation.
- Working experiences of similar project in NCDDP as preferable.
