### 1. Project Background

The Gulf of Mottama Project is a project of the Swiss Agency for Development and Cooperation – SDC and implemented by consortium partners led by HELVETAS Myanmar, Network Activities Group (NAG), International Union of Conservation and Nature (IUCN). The Gulf of Mottama Project covers in eight townships with 60 targeted villages in Mon State and Bago Region. This project has been implemented since 2015 and is being conducted in 3 phases. As phase 1, the project was conducted from 2015 to April 2018 & Phase 2, from May 2018 to December 2021. For the phase 3, the project will be implemented from January 2022 and will continue until 2024.

The goal of the project is the unique biodiversity of the Gulf of Mottama is conserved and sustainably developed, benefiting human communities that depend on it and increasing resilience to climate change. This project will achieve the following outcomes.

#### 2. Objective of the Assignment

The assignment aims to investigate the status of community-based organizations (CBOs) and civil society organizations (CSOs) supported by the project, to examine the function of the operation system (including the inclusiveness and outreach), their achievements, and to recommend capacity needs and interventions to ensure their sustainability.

### 3. Key Responsibilities

The consultant will be responsible for the development of assessment design, data collection, data analysis, reporting, and presentation of the findings.

The specific responsibilities of the consultant are:

- Initial meeting with GoMP team including project implementing partners
- Desk review on project documents, monitoring data, and reports
- Develop methodology ensuring the participatory approach
- Develop data collection tools, formats, checklists, etc. and finalize it based on the feedback and comments from GoMP team
- Conduct field data collection
- Data entry and data cleaning
- Analyse data by using relevant data analysis tools and methods
- Draft report and presentation
- Report writing and finalization that addressed the feedback of project implementing partners

#### 4. Scope of Work

The consultant shall work closely with the GoMP Team for preparing the design, methodology, interview questionnaires, workplan and providing the technical training to the survey team if needed. The consultant shall be responsible to lead the data collection and producing the quality report.

- The assessment design should be based on the project outcomes and output indicators.
- The data collection method should be applied in line with the local context.
- The consultant shall be responsible to develop the assessment design together with GoMP team.
- Before the data collection, inception report needs to be submitted to GoMP team. The inception report shall include methodology, team structure, targeted villages, participants, assessment tools and questions, workplan with fixed timeframe.
