The Gulf of Mottama Project covers in eight townships with 60 targeted villages in Mon State and Bago Region. This project has been implemented since 2015 and is being conducted in 3 phases. As phase 1, the project was conducted from 2015 to April 2018 & Phase 2, from May 2018 to December 2021. For the phase 3, the project will be implemented from January 2022 and will continue until 2024.

The purpose of the assignment is to assess the livelihood diversification and income opportunities of targeted beneficiaries through the project-initiated credit services.

The main objectives of the assignment are;

- To evaluate all types of project-initiated credit services on income of the beneficiary and most vulnerable household
- To assess the livelihood diversification of the targeted beneficiaries through project-initiated credit services
- To examine the effectiveness and sustainability of the project-initiated credit services

- The consultant shall be responsible to present the findings of the assessment to GoMP team.

- The final report shall involve one case study for each type of project-initiated credit service
