1. Background Context

Network Activities Group (NAG) has been supporting small-scale fishers in the Delta through number of interventions with funding support from LIFT: (i) Improving Fisheries Governance System Project (IFGS – April 2011 to August 2014), (ii) My Culture Project (September 2015 to November 2019), (iii) Improved Co-Management of Ayeyarwady Wetland Resources (ICAWR – April 2017 to January 2020), (iv) Improving Inland and Marine Fishery Governance (IIMFG – February 2020 to September 2024), and (v) CSO led Strengthening Resilience and Protecting Livelihoods for Poor and Vulnerable Fisheries Community (CSRPL – December 2022 to September 2024). Currently, NAG is implementing 2 fishery projects, namely IIMFG in Ayeyarwady and CSRPL in Mon and Ayeyarwady.

1.1 Background of IIMFG Project

Under the Strategic Partnership between LIFT and NAG for **Improving Inland and Marine Fisheries Governance (IIMFG)** has been implemented in 19 townships of Ayeyarwady Region. There are two main partnership goals that the project will be working for; 1) Capable, sustainable and influential national CSOs working at scale on all facets of small-scale fisher livelihoods and decent work in Myanmar's fishery sector; and 2) An informed LIFT Board and management engaging proactively with civil society for strengthened resilience and sustainable livelihoods in fisher and riparian communities. This project has six outcomes:

1.2 Background of CSRPL Project

CSO-led Strengthening Resilience and Protecting Livelihoods for Poor and Vulnerable Fisheries Community Project aims to "Building Resilience and Protecting the Livelihoods of the Fishery Communities in Ayeyarwady and Mon" is directly addressing the emerging food and nutrition security issues in Myanmar through sustaining production, creating employment opportunities and providing access to finance that will contribute to the improved nutrition and health of fishers and landless community.
